**New Jersey Department of Human Services
Division of Aging Services Webinar**

The Any Willing Qualified Provider (AWQP) is a Department of Human Services (DHS) nursing home quality improvement initiative, which is being implemented under Managed Long Term Services and Supports (MLTSS). AWQP will require Medicaid certified nursing facilities (NFs) serving MLTSS participants to meet Quality Performance Standards (QPS) as a means to raise the overall quality of care and establish standards for moving from state-set rates to negotiated, value-based contracting.

You are invited to choose one of the dates listed below for this webinar which will present an overview of the appeal request and the quality performance plan (QPP) report.

NFs will have the opportunity to appeal data results that impact or may impact their AWQP designation. The QPP report is an action plan created by the NF to address any of the seven measures that fall outside the State benchmark. The QPP report is used to support the NF's continuous quality improvement efforts.

LeadingAge National Launches Learning HUB

LeadingAge National has recently launched its new **Learning HUB** website, a portal for accessing various online training materials, webinars, PowerPoint presentations, recorded seminars/sessions, and more. Some of the offerings are free, while others require a nominal fee or are viewable by members only.

Both housing and healthcare related educational topics are offered. Members can choose from 'QuickCast' trainings which are no longer than 15 minutes to 'Spotlight' trainings that are a half hour to an hour, while 'Webinars' and 'Sessions' go up to an hour and a half, and 'Deep Dives' that are greater than 2 hours. Documenting the Benefits of Comprehensive Culture Change

According to a recently released study by the LeadingAge LTSS Center @ UMASS Boston, comprehensive adoption of person-centered care and the household model can enhance interactions between nursing home residents and their care partners, improve nursing home residents' dining experience, and reduce residents' depressive symptoms.

Tax Incentives for Charitable Giving - Seniors Action Network

LeadingAge and Volunteers of America have sent out a joint alert on H.R. 5771, the Charitable Giving Tax Deduction Act. The legislation would boost tax incentives for charitable donations by allowing all taxpayers a deduction for their contributions whether or not they itemize on their tax returns. LeadingAge and Volunteers of America's message to House members urges them to cosponsor this legislation.

2019 Labor, Health and Human Services Appropriations

The Labor, Health and Human Services Appropriations measure funds home and community-based services under the Older Americans Act, healthcare workforce programs, low-income home energy assistance, Community Services Block Grants, Lifespan Respite Care, and Social Services Block Grants, and geriatrics education, all of which are important to older people living in community settings.

On July 11, the House Appropriations Committee approved a spending measure that mostly level-funds these programs; several of these programs received a spending boost in the 2018 appropriations measure enacted in March. The allocations for programs under the bill approved by the committee exceed the budget requests made by the Department of Health and Human Services.

The Senate Appropriations Committee approved its own measure last month. The next step for both bills is floor votes in their respective houses. Neither bill has been scheduled for floor consideration as yet, however, and these programs likely will be funded by some form of continuing resolution from the beginning of fiscal 2019 on October 1 through the November elections.
